The amendment term is effective July 1, 2021 for a period of 60 days. A motion was made by Carol Loshbough and seconded by Anthony Coleman to approve the MOU between the City of Elkhart and FOP Lodge 52 amending Article 22 Section 9. Carol asked the union to come forward and let the Board know if the union is in full agreement with this. Jason Ray, President of the Fraternal Order of Police Lodge No. 52 told the Board they have been working with the Administration on this and they think this is the best thing for the Police Department at this time. Carol commended them for being proactive during the current circumstances, and thanked the Union for being in agreement and making some changes to help us get through this challenging time. Robert Woods called for the vote, and the motion carried 4-0.

MEMORANDUM OF AGREEMENT BETWEEN LOCAL #338, INTERNATIONAL ASSOCIATION OF FIREFIGHTERS AND THE CITY OF ELKHART, INDIANA

This Memorandum of Agreement (hereinafter referre	d to as "MOA") is voluntarily made and
entered into as of the day of	, 2021, by and between Local No.
338, International Association of Firefighters (hereinafter ref	erred to as "IAFF"), and the City of Elkhart,
Indiana, a political subdivision of the State of Indiana (herein	nafter referred to as the "City"), acting by and
through its Board of Public Safety, (the City and the IAFF co	ollectively to be known as the "Parties"). The
Parties have agreed to the following:	•

- 1. The establishment of the Police Merit Commission requires the City to operate pursuant to Indiana Code 36-8-3.5-13. IC 36-8-3.5-13 requires that a promotion be from the next lower rank. Because each paygrade is currently equivalent to a rank, this has created a bottleneck in certain positions, such as Driver/Operator, where the current holders of these positions do not wish to promote up. In an effort to address the bottleneck presented by certain ranks prohibiting the promotion of members/employees underneath those ranks, the City and the IAFF agree to divorce rank from paygrade and create five (5) ranks:
 - Rank 1: Firefighter
 - Rank 2: Master Firefighter and Driver/Operator (EMS and Fire)
 - Rank 3: EMS Lieutenant, Suppression Lieutenant, Suppression Captain, EMS Captain, and Inspector/Investigator
 - Rank 4: Assistant Battalion Chief
 - Rank 5: Battalion Chief
 - 2. Article 26 of the CBA shall be amended to read as follows:

ARTICLE 26

WAGES AND PAY PROCEDURES

Section 1. The City and the Union have agreed that the following job classification and pay grades shall be covered by this Agreement:

1st Class Firefighter (F6) Inspector/Investigator (F6)

Suppression Captain (F5)

EMS Captain (F5)

Suppression Lieutenant (F4)

EMS Lieutenant (F4)

Suppression Driver/Operator (F3)EMS

Driver/Operator (F3) Master Firefighter (F2)

Firefighter (F1)

Section 2. The annual salary schedule, effective January 1st of each year of this Agreement (except as modified under the provisions of Article 3) shall be set forth on Schedule A. The salary grades shall be set forth in the annual Firefighter Salary Ordinance adopted by the Elkhart Common Council.

Actions While Off-Duty on September 15, 2020

Police Administration was made aware of your actions during the following event and we wish to personally commend and recognize you for your outstanding police work and your dedicated service to the Elkhart Community:

On September 15, 2020, while working off-duty employment for Elkhart County Juvenile Community Corrections, Detective Brandon Roundtree was conducting a home visit in Goshen, Indiana, Upon arrival and exiting his vehicle he heard possible gunshots in the area, but was unable to establish the exact location. Detective Roundtree next witnessed several subjects arguing at a residence several houses from his location. Detective Roundtree saw one of the subjects carrying what appeared to be a handgun enter a vehicle parked close by. Moments later he saw that same male on foot go to the rear of the house and observed an argument. He then witnessed the subject was approaching a female seated in a vehicle, at which point Det. Roundtree visually confirmed the subject was concealing a handgun in his waistband. Det. Roundtree, being off duty at the time, quickly contacted the Communications Center to advise his location and to notify the Goshen Police Department of this situation and to make sure they were aware of his presence before approaching the disturbance. As he approached to make contact a Goshen Police Department officer was arriving on scene, at which point Det. Roundtree ran towards the officer yelling that the male subject had a gun. While the Goshen officer was attempting to secure him the subject resisted and reached for the area of his waistband, Det. Roundtree was able to assist in gaining control and securing the subject in handcuffs.

The investigation by the Goshen Police Department determined that shots had been fired during a domestic altercation and the suspect was in fact in possession of a concealed weapon. The suspect was arrested for battering his wife and a male victim with a firearm.

This letter of commendation is in recognition of your diligent observation, presence of mind and sound actions to intervene with a violent domestic altercation, resulting in the apprehension of the suspect. Your actions, along with the Goshen Police Department, helped mitigate an incident of domestic violence from escalating into what could have easily become a deadly encounter. In March 2021 Ptl. Lamkin responded to an unresponsive medical assistance call at The Artisan restaurant on S. Main Street, where a male had been found unconscious and not breathing in the restroom; CPR was in progress from one of the patrons at the restaurant. The Elkhart Police Administration was made aware of your actions during the following event and we wish to personally commend and recognize you for your outstanding police work and your dedicated service to the Elkhart Community:

In April 2021 officers responded to a call in reference to a shooting victim with injuries. Cpl. Carver was the second officer to arrive on scene of a five year old boy that had been accidently shot by a six year old boy while both were playing with a gun. Upon arrival the mother and the uncle were rendering aid, both in a state of panic. Cpl. Carver was able to ignore the chaos, access the wounds and immediately started administering life saving techniques on the five year old victim. The boy was semi-conscious and in a great deal of pain. He applied a compression bandage on the wound, while talking and comforting the young boy, keeping him awake until the Elkhart Fire Department paramedics arrived on scene and took over his care. As paramedics were loading the victim for transport Cpl. Carver continued to assist by providing information about his wounds, type and caliber of the firearm, all vital information for his future treatment. The young boy was transported directly to Memorial Hospital to then be flown to Riley Children's Hospital in Indianapolis. EFD medics communicated that due to Cpl. Carver's actions at the scene, paramedics were able to immediately transport the victim and that although he was in serious condition he would survive. It was confirmed by both the fire chief and physician that Cpl. Carver's actions more than likely saved the boy's life.

Recently Cpl. Carver had attended an advanced firearms training course in New Mexico. He personally paid for the course, the airfare and used his own vacation time in order to attend. Along with the firearms training he was also taught life saving techniques for serious trauma, specifically treating gunshot wounds. At this training he was given an "Israeli" compression

bandage that he carried on duty; this bandage was the very one that he used to save this young boy's life. Cpl. Carver is a Field Training Officer and on this day he was training a new officer when they responded to the shooting call. While preparing for his arrival to the scene he continued to provide instruction to the officer he was training. Body camera footage shows him holding the bandage in his hand prior to his arrival, opening the bandage as he runs up to the residence.

Cpl. Carver's willingness to seek out specialized training at his own expense in order to better serve the citizens, his dedication to the Elkhart Police Department and his actions saving this young boy's life go above and beyond the normal call of duty. His training, quick actions and calm professionalism during a chaotic and traumatic event are to be commended.

This letter of commendation is in recognition in the manner in which you handled this incident; your ability to take control, access the situation and immediately, without hesitation, take action in rendering aide to save a life. Please continue to be an example to your fellow officers and keep up the great work. Your actions reflect highly upon the Elkhart Police Department and the law enforcement profession. The Elkhart Police Administration was made aware of your actions during the following event and we wish to personally commend and recognize you for your outstanding police work and your dedicated service to the Elkhart Community:

In May 2021 Ptl. Gray was dispatched to a gas station in reference to a female unconscious and not breathing. Upon arrival Ptl. Gray located the female sitting in a vehicle. At that point Ptl. Gray placed the female, who was turning blue and not breathing or conscious, on a flat surface outside the vehicle. He accessed her condition and immediately started CPR completing six rounds before the medic units arrived. After medics took over CPR he could then collect information to assist the medics in what took place. The Elkhart Fire Department Medics, other Fire Department personnel and EGH physician, Dr. Quiring, stated without the quick thinking and response from Ptl. Gray she may have succumbed to her injuries.

This letter of commendation is in recognition in the manner in which you handled this incident; your ability to stay calm and level headed, taking control accessing the situation and immediately take action in rendering aide to save a life. Your actions reflect highly upon the Elkhart Police Department and the law enforcement profession. We are happy to recognize you and were proud to work alongside you. Congratulations and thank you on a job well done.

POLICE MERIT COMMISSION Monday, May 24, 2021

President James Rieckhoff called a meeting of the Police Merit Commission to order at 9:00 a.m., Monday, May 24, 2021. Clerk of the Commission Nancy Wilson called the role. Commissioners James Rieckhoff and Brad Billings attended in person. Clifton Hildreth, and Jean Mayes attended on WebEx. Thomas Barber was absent at roll call.

APPROVE AGENDA

On motion by Jean Mayes, seconded by Brad Billings and carried 4-0, the agenda was amended to allow the President to sign on behalf of the Commissioners not present. On motion by Brad Billings, seconded by Jean Mayes and carried 4-0, the amended agenda was approved.

2. MINUTES- April 26, 2021

On motion by Brad Billings, seconded by Cliff Hildreth and carried 4-0, the minutes from April 26, 2021 were approved as presented.

3. POLICE DEPARTMENT

Chief Kris Seymore notified the Commissioners that Cpl. James Ballard #320 submitted a letter indicating his intent to retire from the Elkhart Police Department effective May 25, 2021. Cpl. Ballard was hired on September 9, 1997, and upon his retirement he will have served the Elkhart Police Department and the citizens of Elkhart for 24 years. Chief Seymore said it is always bittersweet when we have retirements for people who have sacrificed a large part of their lives, and we add Cpl. Ballard to that group. We appreciate the service he has given and we wish him well in the future. Cliff commented that Jim was a good Officer. Jim Rieckhoff noted that Cpl. Ballard is retired and goes with our thanks. Jean Mayes asked the Chief to let Jim know she will miss him on the job, but she will see him off the job.

Chief Seymore presented a Disciplinary Notice for Captain Bryan Moore. An internal complaint was generated on February 19, 2021 and was investigated. The investigation recommended the allegation of violating Policy 26.1.1(F) Immoral Conduct and Policy 26.1.1(G) Conduct Unbecoming be sustained. Chief Seymore agreed with the findings and issued a three-day suspension without pay. Jim Rieckhoff noted this is a matter which is entirely within the Chief's discretion, so the Commission needs to take no formal action other than to accept the notification. The Commissioners had no comments or questions for the Chief regarding the Disciplinary Notice.

Chief Seymore notified the Commissioners that he offered charges of misconduct against Cpl. Taryn Lanzen pursuant to Indiana Code 36-8-3.5-17. He recommended to the Police Merit Commission termination from employment with the Elkhart Police Department. The Professional Standards Investigation substantiated violations of Policy 320.5.2 Ethics, Policy 320.5.4 Relationships, Policy 320.5.8 Performance, Policy 320.5.9 Conduct. Based upon the allegations, the offered charges of misconduct are Immoral Conduct, as that term is used in I.C. 36-8-3.5-17(b)(2)(F), Conduct injurious to the public peace or welfare as that term is used in I.C. 36-8-3.5-17(b)(2)(G), and Conduct unbecoming a member as that term is used in I.C. 36-8-3.5-17(b)(2)(H). On motion by Jean Mayes seconded by Clifton Hildreth and carried 4-0, the Police Merit Commission accepted the Notification of Charges for Cpl. Taryn Lanzen and set a hearing date of June 17, 2021 at 9:00 a.m. in the

The Professional Standards Investigation substantiated violations of policies 320.5.2 Ethics, Policy 320.5.8 Performance, Policy 320.5.9 Conduct, Policy 320.5.8 Performance. Based upon the allegations, the offered charges of misconduct are Immoral Conduct, as that term is used in I.C. 36-8-3.5-17(b)(2)(F), Conduct injurious to the public peace or welfare as that term is used in I.C. 36-8-3.5-17(b)(2)(G), and Conduct unbecoming a member as that term is used in I.C. 36-8-3.5-17(b)(2)(H). On motion by Jean Mayes seconded by Brad Billings and carried 4-0, the Police Merit Commission accepted the Notification of Charges for Sgt. Nathan Lanzen and set a hearing date of June 18, 2021 at 9:00 a.m. in the Common Council Chambers of the Elkhart Municipal Building, 229 South Second Street, Elkhart, Indiana.

FIRE MERIT COMMISSION Monday, May 10, 2021

President Jim Rodino called a regular meeting of the Fire Merit Commission to order at 3:30 p.m., Monday, May 10, 2021. Clerk Nancy Wilson called the role. Commissioners Jim Rodino, Mandy Leazenby, Cary Miller, and Doug Bowlby attended in-person. Commissioner Rev. McNeal Stuart was absent.

APPROVE AGENDA

On motion by Mandy Leazenby, seconded by Cary Miller and carried 4-0, the agenda was approved as presented.

2. MINUTES April 26, 2021

On motion by Mandy Leazenby, seconded by Doug Bowlby and carried 4-0, the minutes from April 26, 2021 were adopted.

FIRE DEPARTMENT

Chief Edgerton presented four prospective firefighters to be sworn in and hired. Doug Bowlby made a motion to hire. Jim Rodino asked the Chief the status of the Fire Pension approval. Chief Edgerton said they have all met all of the requirements and have been accepted by the Local Pension Board. Their paperwork is at the State. Jim Rodino asked if they will have medical coverage and the Chief said yes. Cary Miller asked him when the paperwork from the State will come back? The Chief said it normally takes 2-3 weeks. Cary asked when he wanted to start them on shift? The Chief said they are starting their training tomorrow. Cary said there is a conflict. They are trying to look out for these individuals. They don't want them to start until their paperwork is back. Chief Edgerton said they are approved locally and the State is a formality. Cary said if one of them gets hurt, injured, or dies, what happens? The Chief said in his 30 years, he has never seen anyone accepted by the Local Pension Board that was not accepted by the State. Chief Edgerton asked Doug Bowlby since he was on the Local Pension Board for many years if he had ever seen that? Doug said no, once they are approved and accepted locally they are approved at the State. Chief Rodney Dale came forward to tell the Commissioners that he sends all of the paperwork to the State. They all passed the State's psychological exams and physicals. He can't submit anything to the Local Pension Board without that. They are done and in our pension system. If someone gets hurt tomorrow, they are in our pension system. They fulfilled every requirement. Jim Rodino asked if two weeks make a difference? The Chief said they are starting the next class tomorrow. Jim said they reluctantly went ahead with the schedules last time because they were behind and PERF was not back from the State with the condition they would not do it again. The Chief reiterated that the paperwork is at the State and they are included in the pension. Once they are approved by the Local Pension Board they are in the pension. The Chief said there seems to an underlying feeling we are doing something to put these individuals in danger. The Chief said they are not putting these individuals in danger in any way, shape, or form. He said I am the person responsible for their well-being and I take that responsibility very seriously. We are not putting them in danger, we are not doing anything illegal, and we are not doing

anything shady. We are moving them forward. Jim Rodino said the nature of the job is a hazardous job. We want to make sure they are covered. Mayor Roberson said they want to make sure the Commissioners are comfortable before swearing them in. If you want to bring them back in two weeks we will. Jim said if they have insurance coverage by being accepted locally, then we are fine with that. The Mayor asked Jim if he would like a Legal interpretation. Rose Rivera was with us and said she could not speak to the PERF coverage without calling down State. Rose said the City can hire them for training with or without the PERF pension. Mandy Leazenby said moving forward we should have it, even if it is a formality, but she was comfortable with moving forward today by letting them begin training in the classroom. Cary said it is more than classroom, they work out with weights and physical training. The Mayor said we need to adjust until the Board is comfortable. Doug Bowlby asked the Chief Training Officer if he could clear the air. Chief Kornrumph said the first two weeks are hazmat classroom stuff. The class is controlled. If we postpone this, it will cancel the whole State Course set to start tomorrow. He asked them to move forward with swearing them in and starting the recruit academy because they will not be in life or death situations. They learn live fire in a month or two. The State Course number is ready to go tomorrow. The State does not budge on that. You are assigned that course a month in advance. Chief Kornrumph has been the training Chief for more than four years. Doug said he has never seen new recruits ever put in any danger. It has been standard procedure for years. The Mayor said he was not sure if they could legally swear them in and nothing happens in two weeks. He wanted to make sure the Commissioners were comfortable and we are doing it right. Mandy asked for a comment from the Union. Dustin Flagg, President of IAFF Local 338 said he did not see any problem swearing them in today. They passed the requirements and were approved by the Local Pension Board. Their paperwork is submitted to the State. He said the recruits and their families are here and swearing them in is the prudent thing to do. He stood behind the Chief and said we can fix this problem in the future so we do not have to do it again. The Mayor disagreed and asked them to wait two weeks. Doug Bowlby said they had a motion to proceed. The Mayor apologized to the parents. Mandy Leazenby said no disrespect to the Mayor, she said she seconded the motion. On the motion to hire Blavne LeClaire, Erik Escobedo, James Dewitt, and Casey Fulmer by Doug Bowlby, seconded by Mandy Leazenby carried 3-1, the Fire Merit Commission hired the four recruits. Jim Rodino was opposed.

The Mayor said the City will swear them in but will not hire them until the paperwork is received from the State. Doug Bowlby asked if they could overnight it. The Mayor apologized to the families and assured them the debate was for the safety of the individuals.

Mayor Roberson swore them in. They repeated after him "I, do solemnly swear to faithfully execute the duties as a Probationary Recruit for the Elkhart Fire Department for the next 14 weeks: to selflessly serve the citizens and members of the Elkhart Fire Department with respect, honor, and integrity. I will uphold the mission of the department, the Constitution of the United States of America, the State of Indiana, and the laws, ordinances, rules and regulations of the City of Elkhart and the Elkhart Fire Department." He thanked them for being duly sworn in. The Commission to a brief recess to allow for photos and family time.

FIRE MERIT COMMISSION Monday, May 10, 2021

The Chief asked the Commissioners to leave the Amendments to the Merit Commission Rules on the table to allow the Administration, Union, and Legal to meet prior to consideration.

4. ADJOURNMENT

On motion by Cary Miller, seconded by Doug Bowlby and carried 4-0, the City of Elkhart, Indiana Fire Merit Commission was adjourned 4:14 p.m.
