Pascual Dalizaya, the owner of the property located at 2731 Pleasant Plain Ave. is requesting a credit on the utility bill caused by a leak in the house. See attached letters and supporting documents.

Mr. Dalizaya states that a leak started in the house in or around March of 2022 near the water meter and main valve with repairs shortly after. Mr. Dilzaya also states that after these repairs were made subsequent leaks were located in a toilet and a pinhole leak in a water line — all of which were repaired.

During the time these leaks were being identified and repaired multiple bills had accrued with nearly a 50% increase over typical consumption.

Mr. Dalizaya is requesting a credit on the excess balance outside the typical consumption.

This property is currently on "Summer Sewer Max" and is not eligible for a sewer credit.

Under the current policies, the Utility does not support the issuance of a credit as the water passed through the meter.

Request for Approval of Public Works and Utilities Policy for Mercury-Free Purchasing

Public Works and Utilities (PWU) respectfully requests the approval of the attached City of Elkhart Public Works and Utilities Policy for Mercury-Free Purchasing. PWU currently has a Streamlined Mercury Variance that raises our monthly average discharge limit from 1.3 ng/l to 1.6 ng/l (roughly equivalent to one sixth of a drop of mercury per day). Part of the requirements of the Streamline Mercury Variance include reviewing purchasing policies to reduce or eliminate mercury-containing equipment.

City of Elkhart Public Works and Utilities Policy for Mercury-Free Purchasing August 2022

I. POLICY

As part of an ongoing efforts to minimize mercury being released into the environment and ensure the safety of staff and visitors, the City of Elkhart Public Works and Utilities (PWU) will, to the extent possible, avoid the purchase of equipment or materials that contain mercury.

II. PURPOSE

This document provides guidelines for purchasing activities to minimize mercury in the discharge from the City of Elkhart's publicly owned treatment works. In complying with this policy, PWU will seek to replace products that are known or suspected to contain mercury wherever it is economically responsible and is not detrimental to the proper functioning of PWU.

III. GUIDELINES

- Whenever possible the use of equipment and materials containing mercury should be minimized or eliminated. Products that contain mercury should be avoided whenever feasible as long as mercury free alternatives exist and will not compromise the operation of PWU.
- 2. The Utility shall request information or otherwise verify the mercury content when purchasing any supplies or equipment listed in Attachment A. PWU may incorporate a mercury disclosure requirement into the standard purchase agreement. The disclosure should require the supplier to specify the amount of mercury contained in products to be purchased.
- Where alternatives to mercury containing equipment or supplies are not feasible, preference shall be given to low-mercury alternatives as much as possible until mercury-free alternatives become available.
- 4. Periodically the Utility will evaluate and modify the purchasing process based on the results and efforts made to reduce the presence of mercury at PWU.

The City has appropriated \$400,000 of American Rescue Plan Act dollars to fund the Small Business Continuity Program. These funds will be awarded in 2 rounds of \$200,000 each. The deadline to apply for funding from the first round was January 31, 2022. Notification of award from the first round was February 28, 2022. There are two primary goals of the program. The first is to provide relief where needed for immediate routine expenses like rent/mortgage and utilities. The second is to help small businesses build the capacity needed to adjust and rebound from unexpected challenges. Examples of permissible uses for capacity building are technology upgrades, training, technical assistance, signage or façade upgrades, supply change diversification, space expansion or reconfiguration, and marketing.

More information about the grant program is outlined below:

Eligibility and Selection Criteria

Applicants could request funds up to 10% of total revenue from 2019. If the business was not open a full year in 2019, you may use 2020. Requested funds may not exceed \$25,000. In order to be eligible for the Small Business Continuity Program a businesses must:

- Have a physical location within the City of Elkhart
- Currently have on-going business activity
- Have \$500,000 or less in annual revenue
- Employ 25 or fewer employees
- Be able to demonstrate financial harm due to the COVID-19 pandemic. Examples include:
 - o The business being forced to close for a week or more due to a consequence of the pandemic like public health requirements, supply chain disruption, or labor shortages
 - o Decrease in profit/increase in losses in 2020 and/or 2021 due to the pandemic
- Submit all required reports

- o Required reporting include but may not be limited to
 - 2019 and 2020 tax returns (only 2020 if you were not open in 2019)
 - Payroll documents to demonstrate payroll levels (ex W-3 or 941)
 - Estimates from vendors
 - Other documents that may demonstrate economic harm as requested

Allowable Uses

There are two primary goals of the program. The first is to provide relief where needed for immediate routine expenses. The second is to help small businesses build the capacity needed to adjust and rebound from unexpected challenges.

Examples of permissible uses include:

- Rent/Mortgage
- Utilities
- Technology upgrades that increase resiliency
 - Website and/or App Development
 - o Inventory Tracking System
- Training and Technical Assistance
- Signage or Façade Upgrades
- Expand or Diversify Product Offering
 - o Additional Supplies and Materials
 - o Expand or Reconfigure Space
- Marketing and Promotion

Applicants Could Request:

- Up to 10% of total revenue from 2019 or 2020 if you were not open the entire year of 2019 but not to exceed \$25,000
- Applicants could request funds for a combination of any of the allowable uses

Payment of funds will be made directly to the vendor of the product or the service provider chosen by the business owner.

WHEREAS the City of Elkhart is a municipal corporation located in Indiana and as such, has certain terms that must be included, or must not be included, in every vendor agreement.

WHEREFORE, the City of Elkhart, by its Board of Public Works, and Boostlingo agree to the following amendments to the attached Customer Terms of Service:

- That the City of Elkhart is a public entity and subject to the Indiana Open Door Laws
 and both parties agree that nothing in the Terms of Service prevents the City of Elkhart
 from providing any copies of any translated documents or recordings;
- 2. That the Customer Terms of Service has been amended to strike Section 6.2 entitled "Due Date; Late Payments" in its entirety and replaced with the following:
 - a. Due Date. Amounts due for Products may be invoiced by Boostlingo monthly or as otherwise expressly provided in the Order Form. Customer agrees to pay the net amount of each invoice without offset or deduction within thirty (30) days after the date of Boostlingo's invoice (unless otherwise noted on the invoice).
