CALL TO ORDER

This meeting was held in-person, telephonically, and virtually through WEBEX. Due to the nature of the meeting Dana Donald will call roll after the motion.

The meeting was called to order at 4:00 p.m. by Ms. Schreiber, President.

APPROVAL OF AMENDED AGENDA

Motion made by Mr. Bullard seconded by Mr. Holtz to amend the agenda. Ms. Schreiber made a roll call vote. Four were in favor and none were opposed. Vote carried.

APPROVAL OF NOVEMBER 10, 2020 MEETING MINUTES

Motion made by Mr. Steffen seconded by Mr. Holtz to approve the minutes from the previous meeting. Dana Donald made a roll call vote. Four were in favor and none were opposed. Vote carried.

NEW BUSINESS

- a) 2021 Redevelopment Commission Meetings and Pre-Agenda Meetings:
- h) Approval of Invoice for Foundry Mediator Services for April 2020 and July 2020: Mr. Boyn stated that the Commission employed Ice Miller, LLP to seek recovery of City costs and damages arising from the environmental contamination at the former Elkhart Foundry site. The Contract for Services requires the City to pay for Mediation expenses as incurred, an unsuccessful mediation occurred in April of 2020, and the parties met again in July of 2020 at a second attempt to resolve the litigation by mediation. The Mediator has submitted a bill for all services through July 31, 2020, the balance due on the Commission's 1/3 share, after application of prior payments, is \$3043.88 to be paid from the Downtown Allocation Area No. 1 Special Fund.

Motion was made by Mr. Bullard seconded by Mr. Holtz to approve the resolution. Ms. Schreiber asked for questions or comments from the Commission or public. The roll call vote was as follows: Ayes: Mr. Steffen, Mr. Bullard, Mr. Holtz and Ms. Schreiber. Nays: None. The motion carried unanimously 4-0, and the motion passed.

d) 1101 E Beardsley – Property Appraisal Request: Mr. Fann stated that Staff has been contacted by a developer interested in 1101 Beardsley and 1701 Sterling. Both of these properties were acquired via tax sale. Additionally, both parcels are involved in the MACOG grant for environmental analysis. This developer has experience with development of brownfields and has worked around the State of Indiana. Staff would like to request an appropriation from the Downtown TIF of a not to exceed amount of \$2,800.00 to cover the costs of the appraisals. 1701 Sterling was appraised in March of 2019.

Motion was made by Mr. Bullard seconded by Mr. Steffen to approve the resolution. Ms. Schreiber asked for questions or comments from the Commission or public.

The roll call vote was as follows: Ayes: Mr. Steffen, Mr. Bullard, Mr. Holtz and Ms. Schreiber. Nays: None. The motion carried unanimously 4-0, and the motion passed.

- e) Lawn Maintenance Proposals Approval of Service Contract: The Commission needs the services of a lawn care company to perform lawn mowing, leaf pickup, and snow removal services for various properties under its control; about 20 requests were sent out and we received two quotes. The prices quoted are on a per site visit basis so the actual costs per year will depend on how many times each service is needed and performed. The Commission has reviewed the quotes received and finds the quote of Frankenberger Lawn Care, LLC the lowest and most responsive for Mowing and Leaf Pickup and the quote of Dave Gunn Lawn Service the lowest and most responsive for Snow Removal and the contracts are awarded as such for calendar years 2021 and 2022. The Commission appropriates the sum of \$146,000 to cover the estimated cost of the services, to be allocated among the named Special Funds in the following amounts:
 - \$90,000 from the Downtown Allocation Area No. 1 Special Fund
 - \$8,000 from account 294
 - \$6,000 from Elkhart Technology Park Allocation Area Special Fund
 - \$40,000 from the Consolidated South Elkhart Economic Development/Redevelopment Area Allocation Area Special Fund
 - \$2,000 from the Elkhart Capital Outlay Fund for the River District

At the end of the two-year period, all unspent funds shall be returned to the appropriate accounts.

Motion was made by Mr. Steffen seconded by Mr. Holtz to award the Mowing and Leaf Removal to Frankenberger Lawn Care. Ms. Schreiber asked for questions or comments from the Commission or public.

The roll call vote was as follows: Ayes: Mr. Steffen, Mr. Bullard, Mr. Holtz and Ms. Schreiber. Nays: None. The motion carried unanimously 4-0, and the motion passed.

Motion was made by Mr. Bullard seconded by Mr. Steffen to award the Snow Removal to Dave Gunn Lawn Service. Ms. Schreiber asked for questions or comments from the Commission or public.

The roll call vote was as follows: Ayes: Mr. Steffen, Mr. Bullard, Mr. Holtz and Ms. Schreiber. Nays: None. The motion carried unanimously 4-0, and the motion passed.

Motion was made by Mr. Bullard seconded by Mr. Steffen to approve the \$146,000 over two years allocated from the TIFs as outlined with any remaining amounts returned to their Funds. Ms. Schreiber asked for questions or comments from the Commission or public.

The roll call vote was as follows: Ayes: Mr. Steffen, Mr. Bullard, Mr. Holtz and Ms. Schreiber. Nays: None. The motion carried unanimously 4-0, and the motion passed.

<u>Downtown:</u> Mr. Fann stated that Central Park is technically open. The Parks Department, volunteers, and Ms. Elsasser have put up Christmas decorations.

Economic Development Projects

Ms. Elsasser stated that there are still a couple lights to put out this week. I have also partnered with the Downtown Merchants Alliance to create a Facebook page called Downtown to You – Elkhart's way to buy from our local stores and have your items delivered to you the same day.

Council Person Tonda Hines stated that she received a couple calls about people climbing on the pontoon that is placed on the grass in Central Plaza. We don't want any injuries and/or lawsuits.

Ms. Elsasser stated that she never thought of that. She'll have the Parks Department put a fence around it, have the ladder taken off, and place some signs around it.

Cassopolis Street Projects

Mr. Fann stated that you heard about the Wayfinding earlier, just wrapping things up, and the overpass is still in the design phase.
