

## **SUMMARY**

The Elkhart Urban Enterprise Zone Emergency Relief Fund is for locally owned, small businesses located within the City of Elkhart's Urban Enterprise Zone that have been economically impacted by COVID-19 related loss of revenue. This is a grant and requires no repayment of awarded funds.

## **PRIORITY OF FUNDING**

Businesses located within the Elkhart Urban Enterprise Zone (*see map*).

*Awarded funds are to be utilized only for addressed locations listed in the application within the Elkhart Urban Enterprise Zone designated area.*

## **AWARD AMOUNTS**

Applicants may request grants up to \$5,000.00. However, to aid as many local businesses and organizations as possible, the Elkhart Urban Enterprise Association encourages applicants to consider the needs of their business/organization and make a request for an amount suitable for the individual organization. More local partners can benefit from this program in this time of economic recovery if applicants exhibit consideration and compassion for their local business/organization neighbors.

## **OTHER QUALIFICATIONS**

This program is intended to alleviate some of the economic effects the COVID-19 pandemic and subsequent mitigation efforts have had on businesses and organizations within the Elkhart Urban Enterprise Zone.

## **USE OF FUNDS**

The primary objectives of this grant are general operation needs, to settle fixed debts, accounts payable, and other bills that could have been payed otherwise if not for the economic disruption caused by the pandemic and mandated mitigation efforts. The replacement of lost sales or profits or business expansion are not permissible uses. Examples of permissible uses include, but are not limited to are:

- Rent
- Mortgage payments
- Lease payments
- Utility payments (i.e. phone, internet, security, electric, or water)
- Subscriptions
- IT Support license fees

**Funds will be used to pay those vendors directly.**

## REPORTING

Recipients are required to provide documentation to illustrate the appropriate use of funds. Requested documents may include but are not limited to:

- Income statement / P&L statements
- Balance Sheets
- Invoices
- Other

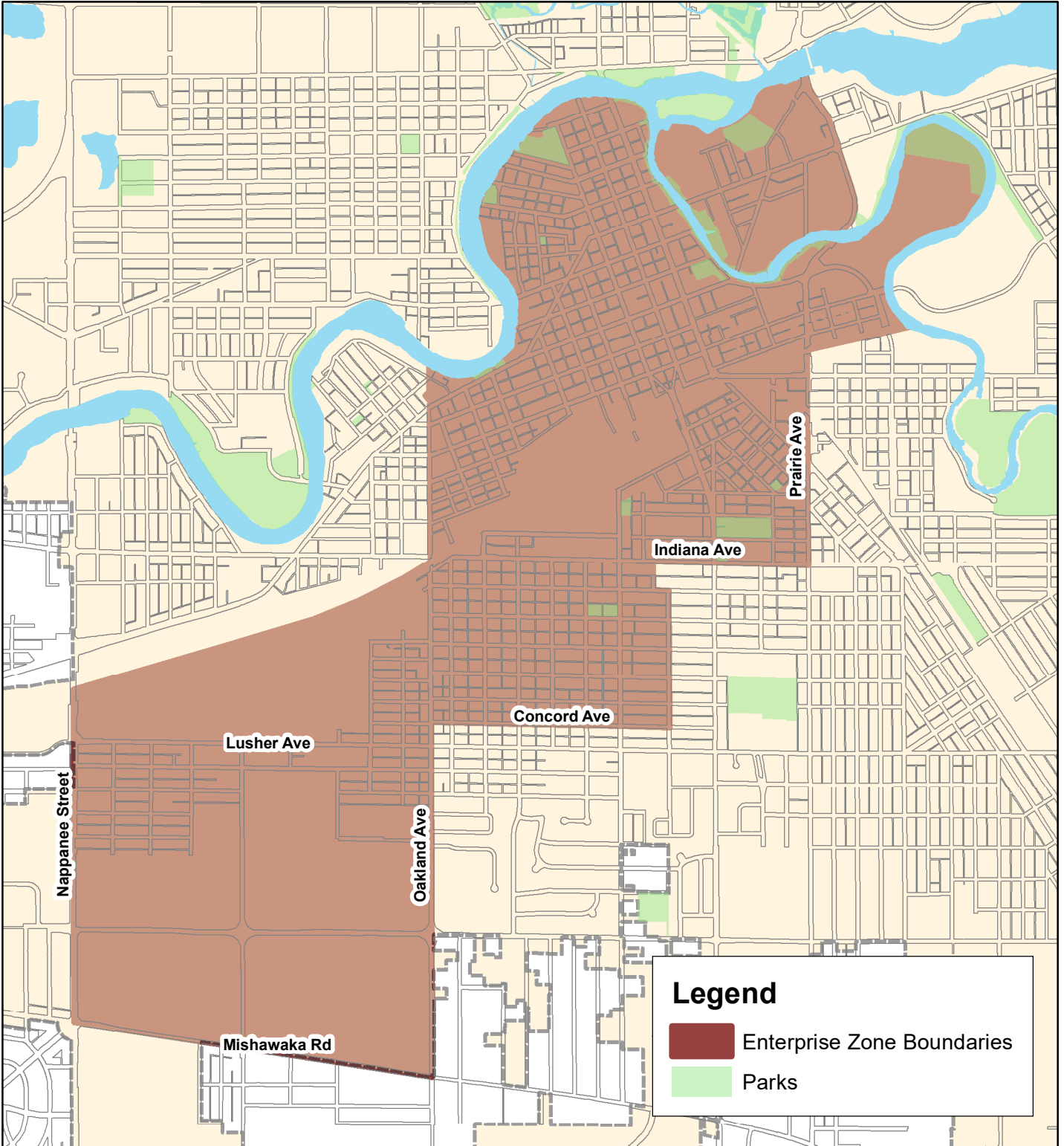
