# 6. Old Business

#### a. Permission to Launch Rockets in Parks

Mr. Czarnecki informs the Board that there are two ways to go about this. The board can change the ordinance to include model rockets or they can continue to give variances to citizens for permission. The county parks allow rockets. Goshen Parks allows them through a variance through their Park Board.

Mrs. Henke inquires if the legal department has vetted the variance to the ordinance. Mr. Czarnecki states that it has not. Mrs. Henke states that she would prefer to have the Legal Department vet it first.

Mr. Dan Bayes informs the Board that his rockets are made out of cardboard and balsa wood. There is an explosion, but it happens in the air. The explosion is only enough to pop the wadding and the parachute. He launches his rockets from a metal plate that deflects the flames and he has a sprayer in case the grass catches fire. He will not launch if there is wind or too dry.

The Board expresses an interest in providing a variance. Mr. Czarnecki states that he will work with the Legal Department on this.

# b. Transfer of Properties to Redevelopment Commission

Mr. Adam Fann of the Department of Development Services informs the Board that the Redevelopment Commission funded a study in 2014 and using tax sales and FEMA money, they have acquired parcels in the River Vista project area that they will transfer to the Park Department. There are currently 41 parcels that are ready to transfer. This project would expand the RiverWalk and connect where it currently stops at Main Street.

Mr. Czarnecki states that the next step is for the Legal Department to draft the resolution to transfer the Frances Avenue property and the Riverside Drive property to the Redevelopment Commission.

#### 7. Use and Event Permit Requests

#### a. Woof Group Halloween Party – October 29, 2022 – Dr. Frank Booth Bark Park

Mr. Barney Ash, the spokesperson for The Woof Group, presents the permit. This is the third year for the event. The group has breakfast and does outreach to the neighbors around the park. They have a costume contest and will have a disc dog demonstration.
