# INSTRUCTIONS AND FILING PROCEDURE FOR WIRELESS COMMUNICATION FACILITY (WCF) LOCATED IN AN AREA WITH ZONING DESIGNATION: R or B1 (STRUCTURES OVER 70 FEET IN HEIGHT)

A complete Wireless Communication Facility Petition (see page 2) must be filed with the Planning & Zoning Department located at the Permit Center at 229 S. Second Street, Elkhart, Indiana OR filed through our Online Portal: <u>Citizen Portal (civicgov4.com)</u>. **Petitions must be filed no later than the filing deadline dates as shown below** on the Board of Zoning Appeals calendar, and with all required signatures in permanent ink.

#### APPLICANT CHECKLIST – WIRELESS COMMUNICATION FACILITY PETITION

NOTE: For <u>Online Submissions</u> – upload all required documents on <u>Step 5</u> of the Application. Payment will be requested via email AFTER your application has been reviewed for completeness by Staff.

Wireless Communication Facility Petitions (that have a zoning designation of R or B1) are submitted to the Board of Zoning Appeals (BZA) through the Planning & Zoning Department. **A complete WCF Petition must contain the following information:** 

1.	A completed <b>Petition form (see page 4)</b> signed by the legal owner of record of the property that is the subject of the Petition. <b>The owner(s) of record at the time the petition is filed shall be considered the applicant and must sign the petition.</b> If the petition is filed by any person other than the legal owner or the owner's attorney, written authorization of the legal owner authorizing the person to act as the owner's agent for petition purposes must be filed with the petition. If the applicant is not an individual, the name(s) and title(s) of the person(s) who are authorized to execute legal documents for the applicant shall be supplied. Land Contract Purchasers or Renters cannot bring petitions without authorization from the owner of record.
2.	A completed <b>Application for Wireless Communication Facility (see page 5)</b> , including <b>Affidavits (see page 6)</b> .
3.	A full and accurate legal description of the property for which the major subdivision is being requested. <b>The abbreviated version shown on a tax form is NOT an acceptable legal description.</b> A full legal description may be found on the recorded deed or possibly on a certified survey. If the legal description is in a Word or PDF format, please email it to <a href="mailto:PlanningAndZoning@coei.org">PlanningAndZoning@coei.org</a> .
4.	Drawings describing the project.
5.	A filing fee of <b>\$300.00</b> (the amount listed in Section 29.12 of the Zoning Ordinance). The Permit Center accepts Visa, Mastercard, and Discover credit cards or a check made payable to the City of Elkhart.

Failure to meet any of the above requirements will result in your application not being accepted by the Planning Department staff until such time as said requirements are met.

#### WIRELESS COMMUNICATION FACILITY PROCEDURE

- 1. A petition for Wireless Communication Facility is submitted to the Board of Zoning Appeals via the Planning & Zoning Department, located at the Permit Center OR submitted through our Online Portal: <a href="Citizen Portal">Citizen Portal</a> (civicgov4.com). Petitions must be filed no later than the filing deadline dates according to the current Board of Zoning Appeals calendar (see page 1).
- 2. Case preparations are made for Public Hearing by the Planning & Zoning Department staff.
  - Legal advertisement is prepared and sent to The Elkhart Truth for publication 10 days prior to the Board of Zoning Appeals meeting.
  - Public letters are sent to all property owners within 300 feet of proposed Wireless Communication Facility.
  - A Reminder letter is sent to the petitioner and/or property owner(s).
  - Planning & Zoning Department staff prepares a Staff Report.
  - If necessary, a radio frequency and feasibility study is conducted by an independent consultant. The Planning & Zoning Department staff may require a fee of up to \$3,000.00, payable to the City of Elkhart for the purposes of conducting a radio frequency and/or feasibility study with an independent consultant.
- 3. A Board of Zoning Appeals meeting/public hearing is held and Planning & Zoning Department staff (and independent consultant if necessary) presents the Staff Report and the Board of Zoning Appeals makes a final vote for approval or denial of the Wireless Communication Facility.
- 4. Permitting Process (all below forms may be submitted online):
  - A Zoning Clearance Permit application is filled out.
  - A Building Permit application is filled out and the completed application and plans are submitted to the Building Department for Local Plan Review.
  - Applicant is referred to Public Works to determine if a driveway/curb cut permit is required; Board
    of Works approval of curb cut/drive locations must be given at a regular Tuesday meeting.
  - Once the proposed development has passed Local Plan Review, then the Building Permit and Zoning Clearance are issued by the Permit Center Staff and all permit fees are paid.
- 5. Required inspections are conducted by the Building Department and the Planning & Zoning Department staff prior to occupancy.
- 6. A Certificate of Occupancy (CO) is issued by the Building Department.
- 7. The Wireless Communications Facility may be operated.
